## **Church bodies to announce the forgiveness of millions in medical debt affecting 5,888 Chicago families**

**WHO:** The United Church of Christ and a collaboration of Chicago churches  
**WHAT:** News conference/celebration  
**WHEN:** Sunday, Oct. 20, 2 p.m. CDT  
**WHERE:** [Trinity United Church of Christ](#), 400 W. 95th St., Chicago, IL 60628  
**WHY:** To note that \$5.3 million in medical debt has been abolished  
**VISUALS:** Clergy will share the geographic areas targeted and lead a celebration in the sanctuary with music and prayer

**REPORTERS AND EDITORS:** Local, regional and national leaders of the [United Church of Christ](#) will share details Oct. 20 that church donations have wiped out \$5.3 million in medical debt for 5,888 South Side Chicago families. In a news conference at [Trinity United Church of Christ](#), they will talk about the campaign that focused on communities in three specific ZIP codes for debt relief.

Working with the New York-based nonprofit [RIP Medical Debt](#), church bodies raised \$38,000 to buy debt in September at pennies on the dollar. Families are now receiving letters telling them that their debt, averaging \$907, has been forgiven. The urban neighborhoods were chosen because of their demographics, said the Rev. Traci Blackmon, the UCC's national associate general minister for [Justice and Local Church Ministries](#), which contributed to the debt buy. "Medical debt is now the leading cause of bankruptcy in the U.S.," she said. "Such debt further destabilizes the physical, social, financial and spiritual health of families and communities already besieged with economic challenges."

"When medical debt piles up, families have to make difficult financial decisions, sometimes cutting back on food, clothing or other basic household items," said the Rev. Justo González II, leader of the UCC's regional [Illinois Conference](#), another contributor to the project.

"Our prayer is that this release from burden will be a blessing in the lives of thousands of our neighbors," said the Rev. Dr. Otis Moss III, senior pastor of [Trinity UCC](#), the lead congregational contributor whose members made generous donations toward the effort. [St. Pauls UCC](#) in Lincoln Park, [Covenant UCC](#) in South Holland, Ill., and [The Leaders Network](#), a consortium of local Baptist churches serving Chicago's black neighborhoods, are other major contributors.
